Ord. # 94/003 REPEALING ORDINANCE # 002/92 (AMENDING CERTAIN SECTIONS OF THE REVISED LOCAL TAX CODE OF MANDAUE CITY) AND REACTIVATING ORD. # 033/90 (INCREASING THE RATE OF TAXES BY THREE PERCENT (3%) FOR FIVE (5) CONSECUTIVE YEARS STARTING 010191

The Sangguniang Panlungsod of Mandaue City, with members assembled in session, hereby ORDAINS that:

Section 1. Ordinance # 002/92, effective as of 010192, implementing the rates of taxes imposed for taxable subjects and bases under the headings municipalities, provinces and highly urbanized cities in the local government code, RA-7160, which took effect on 010192, is hereby repealed and superseded.

Section 2. Ordinance # 033/90 which was effective as of 010191 but repealed by the effectivity of Ordinance # 002/92 by virtue of the effectivity of the local government code RA 7160, is hereby reactivated in such a manner that the staggered increase in the rate of taxes by 3% per year starting in the year 1991 until 1995 shall be the rate payable and collectible by the taxpayers concerned pertaining to the year 1994.

Section 3. This Ordinance shall take effect 11 days from the date of approval thereof by the Hon. City Mayor, that is, the 10 days' mandatory posting period mandated by the local government code shall have been complied with.

ENACTED unanimously after 2nd and final reading on 012694 as proposed and motioned by Hon. Rafael J. Mayol, seconded by Hon. Paulino D. Dy.
