"ADDITIONAL SERVICES" OF CITY ORDINANCE NO. 52
SERIES OF 1999 OTHERWISE KNOWN AS AN ORDINANCE
ENACTING A REVENUE CODE FOR THE CITY OF
MANDAUE BY ADDING TWO (2) SUB-SECTIONS TO BE
IDENTIFIED AS SUB-SECTION 5 (N) AND SUBSECTION 5 (O)
ON MARRIAGE COUNSELLING SERVICES**

The EIGHTH SANGGUNIANG PANLUNGSOD of
MANDAUE CITY, with members in session duly assembled, hereby
ORDAINS that:

SECTION 1. Section 33 (C) number 5 of City Ordinance No. 52
series of 1999 is hereby modified and amended to include two more sub-
sections to be identified as subsections 5 (n) and subsections 5 (o), to wit:

"C. Miscellaneous Fees

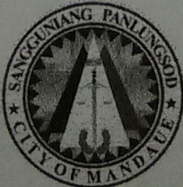

SECTION 3. All ordinances, rules, regulations or guidelines or parts thereof contrary to or inconsistent with the provisions of this ordinance are hereby repealed, amended or modified accordingly.






