
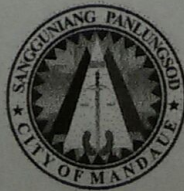
SECTION 1. Article V. - Fees and Charges, Section 32, Paragraph C - Miscellaneous Fees, of city ordinance numbered 99-051 is hereby amended in such a manner that the following entries will be shown or added after the last paragraphs of section 1 (n):

- a. Rabies Immunization P 100.00;
- b. Scabies treatment/protection 100.00;
- c. Dog castration 100.00;
- d. Hog Cholera Immunization:
 - (1) Piglet 30.00;
 - (2) Boar/adult 35.00;

SECTION 2. Prior ordinances, or portions thereof, which are inconsistent herewith are hereby repealed, amended, or modified accordingly.

SECTION 3. This ordinance shall take effect on the day after the completion of the mandatory ten days' posting/publication period, counted from the date of approval hereof by the City Mayor, as required under Section 511 of R.A. 7160.

SECTION 4. Due to the urgent nature of this measure, the City SP Secretary is directed to accelerate the finalization and release of the excerpt embodying this ordinance as an exception to the general rule, that is, without waiting for the time when the journal of proceedings pertaining to the 92nd session shall have been ratified and signed by the SP Members.






