SECTION 1. There is hereby imposed a Public Safety Fee in the amount of Ten Percent (10%) of the total Zoning Permit, Garbage, Sanitary

Inspection and Food & Drugs Fees imposed on every commercial and industrial establishment in the City of Mandaue.

SECTION 2. The public safety fee shall be used to augment the needs of the City Fire Department and the City's own accident and emergency rescue unit (ACERT).



SECTION 4. This ordinance shall be effective on January 01, 2004.




