**AN ORDINANCE AMENDING SECTION 28 OF CITY
ORDINANCE # 99/051 BY INSERTING THE WORD
“SHOPPING CENTER” AND PROVIDING ITS DEFINITION**

The NINTH SANGGUNIANG PANLUNGSOD of MANDAUE CITY, with members in session duly assembled, hereby ORDAINS that:

SECTION 1. Section 28 of City Ordinance # 99/051 is hereby amended to include the words “Shopping Centers or Malls”.

SECTION 2. *Shopping Centers or Malls* shall mean a “Complex or group of stores consisting of food shops and markets and stores of various kinds built together under one roof and having a common parking lot designed to serve the needs of the community”.





SECTION 4. This ordinance shall be effective immediately.


