SECTION 1. Article V, Section 32 (c) Miscellaneous Fees 2. Civil Registry of City Ordinance No. 51 series of 1999 otherwise known as an Ordinance enacting a Revenue Code for the City of Mandaue, is hereby amended to include an additional provision to wit:

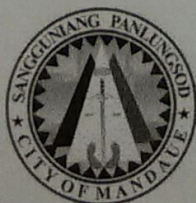
b. *Petition for the correction of a clerical or typographical error in an entry and/or change of first name or nickname in the civil registry. (R.A. 9048 in relation with Administrative Order No. 01-2001)*

i. *Clerical or typographical error* P1,000.00

ii. *Change of first name or nickname* P3,000.00

An indigent petitioner who is certified as such by the City Social Welfare and Development Office, shall be exempt from the payment of the aforementioned fees.

When the petitioner files a petition for correction of clerical or typographical error simultaneously with a petition for change of first name, and the same document is involved, the petitioner shall pay only the amount corresponding to the fee for the petition for change of first name.





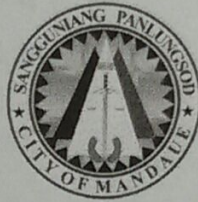

SECTION 2. This ordinance shall take effect immediately following its publication in a newspaper of general circulation.


