**AN ORDINANCE AMENDING SECTION 17 OF CITY  
ORDINANCE NO. 99-051 OTHERWISE KNOWN AS THE  
REVENUE CODE OF THE CITY OF MANDAUE**

The TENTH SANGGUNIANG PANLUNGSOD of MANDAUE CITY, with members in session duly assembled, hereby ORDAINS that:

SECTION 1. Section 17 (3) of City Ordinance No. 99-051 is hereby amended to read as follows:

“(3) Cooking oil and cooking gas such as compressed natural gas and liquefied natural gas except liquefied petroleum gas;”

SECTION 2. *Repealing Clause.* – All other Ordinances or portions thereof that are inconsistent with the provisions of this ordinance are hereby modified, amended or repealed accordingly.


SECTION 3. This Ordinance shall have prospective application.




