

"SECTION 3. - Sub-paragraph "1(4)" of paragraph "1", Section 17 of Tax Ordinance No. 1, is hereby amended to read as follows:

"(4) Corral fee. - Fees at the rates herein below fixed per day or fraction thereof, shall be collected for animals to be slaughtered which are first to be deposited and kept in a corral owned by the City Government:

"Large cattle, per head	"	"	PO.50	per day
"Hogs	"	"	0.30	" "
"Goats	"	"	0.20	" "
"Sheeps & Others"	"	"	0.20	" "
"Fowls, rabbits, etc.	"	"	0.02	" "

"No animal shall be slaughtered for public consumption without its being first deposited and kept in the corral owned by the City Government for the necessary observation for any defect or disease and shall only be slaughtered upon certification of its fitness by the Meat Inspector duly authorized by the City Treasurer."

"SECTION 4. - This Ordinance shall take effect upon approval."

RESOLVED, as it is hereby resolved, to approve, as it is hereby approved, the foregoing Ordinance.

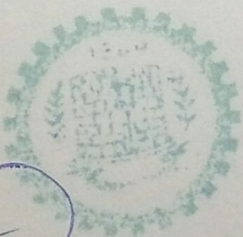

A RESOLUTION APPROVING ORDINANCE NO. 13, SERIES 1976.

* ORDINANCE NO. 13 *
AN ORDINANCE AMENDING CERTAIN SECTIONS OF TAX ORDINANCE NO. 1, SERIES 1974 OTHERWISE KNOWN AS THE MANDAUE CITY REVENUE CODE.

WHEREAS, certain sections of Tax Ordinance No. 1, otherwise known as the Mandaue City Revenue Code, needs some revisions to make the ordinance abreast with the present trends of circumstances;

WHEREAS, the City Treasurer has proposed some rates which are within the rates authorized under Presidential Decree Numbered 231;

NOW, THEREFORE, BE IT HEREBY ORDAINED by the Sangguniang Bayan Ng Mandaue, in session assembled that:

"SECTION 1. - Sub-paragraphs "b-1", "b-2", "b-4", and "b-5", of paragraph "b", Section 17 of Tax Ordinance No. 1, are hereby amended to read as follows:

"(b) Rentals for fixed stalls, booths and tiendas, - Fixed rentals for stalls, booths and tiendas are herein prescribed, to wit:

- "(b-1) Along Zamora Street 36.00 per month
- "(b-2) Along B. Ceniza Street and all stalls along former Suico Street 18.00 " "
- "(b-4) Inside main market building No. 1 18.00 " "
- "(b-5) Booths or stalls inside main market building No. 2 per 1.2 sq. meters 0.80 per day

SECTION 2. - Sub-paragraph "b-6" of paragraph "b", Section 17 of Tax Ordinance No.1, is hereby split into sub-paragraphs "b-6" and "b-7" and amended to read as follows:

- "(b-6) Booths or stalls insided main market building No. 3 per 1.2.sq. meters ₱ 0.40 per day
- "(b-7) Booths or stalls inside main market building No. 4 per 1.2 sq. meters 0.60 " "
