AN ORDINANCE AMENDING ARTICLE V, SECTION 33 OF ORDINANCE NO. 99/051 OTHERWISE KNOWN AS THE REVENUE CODE OF THE CITY OF MANDAUE

The THIRTEENTH SANGGUNIANG PANLUNGSOD of MANDAUE, with members in session duly assembled, hereby ORDAINS that:

SECTION 1. *Purpose*. – This ordinance amends Article V, Section 33 of the Revenue Code of the City of Mandaue (Ordinance No. 99/051) by fixing the rate to be collected for the conduct of Pre-Marriage Counseling Seminar.

SECTION 2. Article V, Section 33 (2) of Ordinance No. 99/051 otherwise known as the Revenue Code of the City of Mandaue, is hereby amended to read as follows:

SECTION 4. *Effectivity Clause*. – This ordinance shall be effective immediately upon its approval by the City Mayor.
