A RESOLUTION APPROVING ORDINANCE NUMBERED 21, SERIES 1978

ORDINANCE NR. 21

AN ORDINANCE ADDING A CERTAIN ITEM TO SECTION 14, OF ORDINANCE NUMBERED 1, SERIES 1974, OTHERWISE KNOWN AS THE MANDAUE CITY REVENUE CODE

BE IT HEREBY ORDAINED, by the Sangguniang Panlunsod ng Mandaue, in session assembled, that:

Section 1. - There is hereby added to subsection "O" of Section 14, Ordinance Numbered 1, series 1974, otherwise known as the Mandaue City Revenue Code, the following:

" (O-17) Booking Station P 1000.00/pa.A "

Section 2. - The term "booking station" as used in this Ordinance shall refer to a Station, Counter or Space designed as a place for transacting business in connection with the offer to sell, sale, distribution on any or all tickets related to a lawful, or legally allowed and authorized games of chance (Jai Alai or Basque Pelota) and does not include those which are held purely for charitable and humanitarian purposes (Philippine Charity Sweepstakes, Philippine National Red Cross and the like).

Section 3. - This ordinance shall take effect upon its approval.

NOW, THEREFORE, on mass motion of the Members of the Sangguniang Panlunsod ng Mandaue, seconded by Them, en masse,

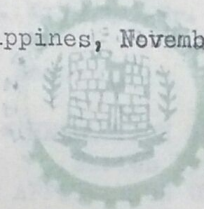
