Ord. # 22/88 ORDINANCE AMENDING FURTHER PARAGRAPH (0-16) OF LOCAL TAX
ORDINANCE # 1-74 OTHERWISE KNOWN AS THE LOCAL TAX CODE OF MANDAUE CITY.

BE IT ORDAINED by the Members of the Sangguniang Panlungsod of
Mandaue City, in session assembled, that:

Section 1. The 14th and 15th line under subparagraph (0-16),
paragraph (0) Section 14, of Tax Ordinance numbered 1-74, as amended by
Ordinance numbered 11-88, is hereby further amended to read as follows:

"per cockfight - ordinary, per sultada P 3.50
per cockfight - d e r b y 7.50"

Section 2. The abovestated rates of taxes per cockfight shall be
due and collectible during the first two (2) years counted from the effec-
tivity of this amendatory ordinance subject to acceleration at the rate
of fifty (50%) per cent of said amount during the three (3) year period
after the first two year and every three-years period thereafter.

Section 3. Violation of the provisions hereof shall render the
violator liable to a fine of not exceeding TWO HUNDRED PESOS (P200.00)
or an imprisonment of not more than six (6) months, or both, in the dis-
cretion of the Court, provided, however that in case the violation is
committed by a juridical person, the maintainer or operator thereof shall
be held liable to the fine or imprisonment, or both.


Section 4. Inconsistent provisions of prior ordinances are hereby
repealed.

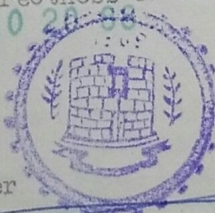
Section 5. This ordinance shall take effect immediately upon its
approval.


PASSED AND ENACTED on its first and final reading upon motion of


